

# Chairperson's Message



This year has been a difficult one for all those working in environments that require engagement with communities and interaction with a large number of stakeholder who expect support and guidance on the ground.

The shifting waves of COVID-19 and the uncertainty it generated has also impacted Sahil. However, despite the restrictions on movements Sahil staff braved the conditions and showed their commitment by keeping its doors open and continued to support families in distress and those turning to it for Free legal and phycological support, and has been able to reach its targets.



Sahil turned to digital and virtual communication channels to offer services to its clients and saw an increase in the number of telephone clients who reached out to it for counseling services.

Sahil's work acquired new significance during the pandemic as there were a lot of indications that during the last two years, the incidence of violence against women and children had increased. Sahil's tracking of Child Sexual Abuse shows an increase (4%) in incidents of cases. This of course should be read with caution as we know that many cases are simply not reported.

There has been increased recognition of Sahil's work in the country. Sahil has been selected by Aflatoun International to implement a new initiative titled "Gender-Sensitive Global Citizenship Education and Life Skills for Youth. This pilot will be implemented in two districts of the provinces of Sindh and Balochistan. Hopefully the modules from the pilot will be scaled up by others in this arena or replicated by Sahil if it is able to access additional financing.

Sahil has continued to impact policy in the country and strengthen the institutional arrangements for child protection. It is a testament to its reputation and a recognition of its work that Sahil has been selected to be on the sub- committee on "Prevention and control of cybercrimes against children". Awareness raising content to protect children from becoming victims of cybercrimes was developed with Sahil's participation in the sub-committee. Sahil's animations on the safe use of computers was used for expanded outreach and broadcast by several TV channels.

On behalf of the Board, I would like to thank our many partners, contributors and donors. I would also like to express our deep appreciation to the management, staff, community members and volunteers of Sahil for their contribution and efforts in achieving Sahil's vison and mission of protection of children.

## Foreword



I am very pleased to share the achievements of Sahil in 2021.

The 3 year project was completed successfully by declaring 4 villages, one in each province, as a child protected model village, "Mera Gaon Mera Mohafiz", where every child speaks up, is heard and protected. In these villages every adult and child was given information on all aspects of child protection. Community Watch Groups were formed for each mohalla and provided with referral lists of local government and NGOs to ensure continued support to the community. All police stations were provided FIR posters for display, showing case registration requirements.



We are extremely grateful to the Royal Norwegian Embassy for the generous support of this project.

Sahil annual publication of child abuse cases, Cruel Numbers report 2020, was launched virtually, due to COVID 19 pandemic restrictions on large events.

In the year 2020, a slight increase can be seen in child abuse cases. These cases have increased 4% as compared to the last year's data of 2019.

The data shows that in a day more than 8 children have been abused during the year 2020. Sahil provided free legal aid to more than 181 victims. Out of on-going cases 13 were decided in favor of the victim.

This year, Sahil is the implementing partner for a 3 year project on "Gender-Sensitive Global Citizenship Education and Life Skills for Youth" in two districts, one in each of the provinces of Sindh and Balochistan. This project is sponsored Aflatoun International which is being supported by ROTA and EAA Netherlands. Youth will be engaged through a participatory learning approach, including practical components to equip youth with skills required to successfully transition from childhood to a life of dignity and respect that they are entitled to. Sahil has also included as partners, six civil society organizations (CSOs) in the program.

I would like to thank all Sahil Board Members for their guidance in this difficult time of COVID- 19 limitations. A special thanks to all the staff, volunteers, and partners of Sahil for their contribution and efforts towards achieving Sahil's vision.



# Child Protected Model Villages "MERA GAON MERA MUHAFIZ"

# Child Protected Model Villages



Sahil has established 4 Model Villages, where "every child speaks up, is heard and protected". The villages were declared as "Mera Gaon Mera Muhafiz" (My village, my protector). These 4 villages, one in each province of Pakistan were Mohar khur Abbotabad (Khyber Pakhtonkhwa), Bhani, Lahore, (Punjab), Roshanabad, Sukkur, (Sindh) and Noor Muhammad Nawra, jaffarabad, (Balochistan).

At the start of the program, a baseline KAP study, and then end line study was done with one member of each household, to assess the learnt knowledge and impact of the program.

These villages were declared child protected after the following interventions.

#### 1. Community Trainings:

Every adult in the village was given awareness on aspects of protection effecting children. The UNCRC child rights, kinds and effects of abuse, child protection messages in book, Meri Hifazat, stages of Child development dealing with adolescent behaviour parenting skills and effects of gender based violence. Each household was provided illustrated posters on each topic.

#### 2. Direct Intervention With Children:

Every child in the village was given a session on mapping their villages' safe and unsafe places. Then they were shown a puppet show on multi media that informed them of dangerous situations and how to protect themselves.

#### 3. Establishing Community Watch Groups (CWG):

In each village, a CWG was formed at the mohalla level to ensure that the community continues to be supported for child protection. They were provided with a complete referral list of contacts with all relevant government departments, and civil society organizations for support services.

Capacity building sessions were held with these CWGs on the following topics:

#### Leadership skills:

This session enhanced the ability of the CWGs to interact effectively with the community members and relevant service providers.

#### Legal procedures:

In case of any child rights violations CWG members were provided sessions on legal procedures required to register cases of child sexual abuse.

After the sessions, the CWG said that their confidence had increased to provide support to the communities, and ensure their contribution to the Model Village to remain safe and secure for children. The formation of Community Watch Group (CWG) also ensures the sustainability of the project.

#### **Refresher on Child Protection Posters:**

In order to strengthen the knowledge base and to ensure sustainability of the model village program, Sahil conducted refreshers essions for Community Watch Group members and community activists.

#### 4. Results of Baseline And Endline KAP Study:

Sahil baseline and end line survey including impact confirms the capacity and sustainability to keep children safe through the following responses of the community.

# Child Protected Model Villages...



It may be noted that end line responses have been given after three years of the baseline and Sahil interventions.

# All community responses show that they are now capable of sustaining a protective environment for their children.

- i. The change in the environment of the households in the responses of the community members is that now they are mainly respecting each other, showing love and affection, discussing domestic issues, and not quarrelling within the family.
- **ii.** Approximately 90% respondents have rejected physical and verbal abuse as ways of disciplining children. They stated new ways of dealing with disobedience, such as, counseling children in a friendly manner, willing to let children think through their behavior, discuss or change the topic, and sometimes even ignore the behavior.

This very important change is the first step for protecting children from further abuse.

- **iii.** The community also realized that abusing children made them more obstinate and disobedient. It further disturbed them mentally/psychologically pushing them into an increase of bad behavior.
- **iv.** Community members were now clear on how to keep their children safe. They emphasized the importance of being informed about their children's friends, not allowing them to go out at night, and keeping an eye on them when they are playing outside. They have also mentioned most of the protection messages that Sahil has given them in the trainings. This was a big change, instead of the vague answers given before, such as, take care of children, protect children, or just keep children at home.
- **v.** Another major sustainability of the project in the four model villages is seen through the commitment of the community to report cases to the police, Sahil and CWGs instead of keeping it to themselves, or sometimes only reporting to the village elders.
- **vi.** After the interventions, Childeren clearly stated the learnt protection strategies such as, not taking free gifts, not visiting deserted houses, and not making older friends. They also shared their confidence to be able to tell parents, older siblings, or a trusted person in case of inappropriate touch or action. Children in Roshanabad, Sukkur protected themselves from abduction attempts in the village.

vii. The community now recognizes the CWGs as an important human resource for protecting children and supporting community needs through a strong referral system.

#### 5. Sahil Community Centres

The purpose of having a community center, including a wash room, in each village was to have a place that could provide the community with a health facility for a visiting lady health worker. It could also serve as a vocational centre for the women, and a play area for children.

# Child Protected Model Village



It was decided that it would be made with contribution from the community and Sahil, and all the mohallas of the village would be able to access it. This unfortunality was not agreed on by two villages.

However, the villages of Bhani, and Noor Mohammed Nawra, established their community centers. Sahil provided the community centers with an examination table for the lady health worker (LHW), a cupboard, a table and a chair.

Sports material such as football, cricket bat, balls, skipping rope,indoor games, and child protection material such as posters, Meri Hifazat book, Sahil magazines, child protection ludo game, and UNCRC card game.

#### Gender-Sensitive Global Citizenship and Life Skills Education for Youth



#### Aflateen+

Aflateen+ curriculum has been developed for youth by Aflatoun international, and the project is suponsored of Reach Out to Asia (ROTA) and Education above All (EAA).

Sahil is a partner organization of Aflatoun International and is a Master Trainer for Aflatoun social and financial literacy program. This provides a unique pathway to implement synchronized strategies that enhances education and creates an inclusive and lifelong learning environment for children.

This new initiative for youth is another participatory learning approach to life skills, including practical components to equip youth with skills required to successfully transition from childhood to a life of dignity and respect to which they are entitled.

Sahil has been selected in Pakistan to implement this project in two districts of the provinces of Sindh and Balochistan. The purpose of this 3-year initiative aims to provide youth with gender -sensitive global citizenship & life skills education through teacher training in 34 schools reaching out to 12,000 students. The schools will establish 69 youth clubs. Youth will be supported to develop entrepreneurial projects to address different social issues. Community dialogues will be held to support the youth programs.

These interventions aim to reach the most vulnerable youth by providing high quality education content which requires them to explore social concepts such as identity, community norms, socio-economic conditions, and provides opportunities for self improvement. With a great emphasis on gender equality, the project intends to engage with educators, practitioners, and government institutions in an effort to advocate for, integrate, and build gender sensitive education in local programming at scale.

All Aflatoun materials are provided with the explicit understanding that the contents are adapted to the cultural norms of the country and translated into the local language.

Sahil has implemented the following activities:

#### Contextualisation and translation into Urdu of the Aflateen+ curriculum and teacher training manual:

Sahil completed the contextualisation and translation of the curriculum and teacher training manual. The copies of the teacher training manual, and Aflateen+ curriculum were shared with Education Departments of Sindh and Balochistan. After incorporation of their feedback, STEDA (Sindh Teachers Education Development Authority) approved the project for Sindh and PPIU (Policy Planning and Implementation Unit) in Balochistan gave their approval for training of teachers in schools.

#### Session on "Girl Roster" application

The Population Council developed the Girl Roster, a practical tool designed to help practitioners understand their community and elicit information to link the most marginalized adolescent girls to the vital resources, facilities, and services to which they often have limited or no access.

All Sahil project staff attended 2 training sessions on "Girl Roster".

#### **Need Assessment Report**

Sahil prepared a "Need Assessment Report" for Sindh and Balochistan. The situational analysis of Educational Contextual Challenges, Educational Situation in schools, Children in Labor, Available Skill Training Opportunities for Youth for Enterprise Development, and Available Financial Support for Youth was documented. Findings of the report emphasized the need for inclusion of Aflateen+ curriculum knowledge and interactive teaching methodologies, entrepreneurship interventions, and project development.

## Gender-Sensitive Global Citizenship and Life Skills Education for Youth



#### School mapping and selection:

A mapping of 34 schools for implementing the program was done in consultation with District Education Officers A total of 17 schools from Sukkur, and 17 schools from Jaffarabad, were visited by Sahil Regional Office teams.

#### **Selection of Civil Society Organizations:**

As a part of the program, Sahil identified and selected 6 Civil Society Organizations (CSO), 3 from Sukkur and 3 from Jaffarabad. These organizations will implement Aflateen+ in informal settings.

#### CSOs Sukkur, Sindh

#### **PEHAL Pakistan:**

Pehal Pakistan is a Non-Government and Non-Profit Organization, a fast growing and leading humanitarian and human development organization in Sindh, and is committed to bring a wider level of social change through utilization of existing social capital; transformation of active participants and change makers from passive and marginalized groups through education, social mobilization, capacity building, establishing social safety nets and advocacy.

#### Riverside Development Organization (RDO):

Riverside Development Organization (RDO) is a non-government and non-profit developmental organization working to equip viable lives of sequestered communities (especially children and women) through the improvement of health, the support of education, securing the natural resources, bringing up the civic sense and the alleviation of poverty.

#### Goth Seengar Foundation (GSF):

GSF envisions a society in which all citizens, irrespective of their gender, class, religion or sect, have equal opportunity for growth, and participation in local and national affairs. The organization aims at empowerment of the marginalized communities and supports the process of their poverty alleviation through direct interventions and advocacy.

GSF identified other thematic areas as community based infrastructure became main objective and gender and environment were added as cross cutting themes. Most of the partner CBOs became implementation partners in community based infrastructure and sustainable livelihood programs.

#### CSOs Jaffarabad, Balochistan

#### Reformist's Social Welfare and Development Organization

Reformist's Social Welfare and Development Organization, also call themselves WORDS, believes that poverty will be reduced only if external support focuses on what matters to people, understand the differences between groups of people and work with them in a way that is congruent with their current livelihood strategies, economic realities, social environment and ability to adapt.

The main purpose of this organization is to focus on the immediate need of general public for their dignified life and prosperity specially women folk. A best practice of entrepreneurship is being inculcated amongst the youth bulge of Pakistan with quality and timely training in various vocational and technical training demand driven trades so as to enable them to have sustainable life on earth.



#### **Chiragh Community Development Organization (CCDO)**

Chiragh Community Development Organization is a local non-political organization. It was established in July 2008. CCDO formed to deal with the present socio-economic problems in different parts of the province by means of good understanding and sharing the problems with each other and to find out the best way of solving the problems through free discussion and people participation in decision making under the umbrella of Chiragh Community Development Organization.

We are committed to ensure community development outreach in far flung areas of the province especially district Jhal Magsi, and expand roots of development across the province, Through building communication with different national, international and United Nation agencies, so that the social development interventions will be initiated at marginalized communities in Balochistan.

#### Gender and Empowerment Organization (GEO)

Gender and Empowerment Organization (GEO) is a non-governmental and non-profit organization.

GEO works on ground to achieve collective goals, in this perspective organization has initiated many activities which directly or indirectly effect to protect human rights and promote active citizenship.

GEO works in close collaboration with communities, elected representatives, policy makers, local organizations and line departments. GEO has linkages with local governments, press, radio, TV, research institutes, women groups, educational institutes, bar associations, professional organization, teacher-students unions, labour and trade unions as well as private sectors

Mobilization, coordination, lobbying, advocacy and media tools were used to achieve the objective of area development in the region. GEO particularly focuses on ensuring maximum participation of vulnerable sections wherever required and relevant either directly or indirectly. GEO works with the holistic approach in taking careful consideration of gender sensitivities and local norms and values.

#### National Stakeholders Conference and Integration Workshop 19-20 Nov 2021

A National Stakeholders Conference was held in Karachi on 19- November 2021 to introduce the Aflateen+ program. The expert's panel of the Conference was Secretory Education Balochistan, Ms. Shahnaz Wazir Ali, renowned educationist, and Mr Junaid Chaudhary Chief Risk Officer, Silk Bank.

Aflatoun International, CEO Mr. Roeland Monasch, welcome video message was shown.

Ms. Manizeh Bano ED Sahil gave a presentation on the Aflatoun program.

Ms. Shahnaz in her keynote speech emphasized the need for inclusion of social and financial education in the curriculum as an important element. It would give the children the practical experience required for them in their daily lives need to be taught how to save and invest.

Mr Junaid Chaudhary said "Nothing is more powerfull than an idea whose time has come." And i think that Social Financial Education (SFE) is an idea whose time has come

The final remarks of Chief Guest Mr. Abdul Rauf Baloch were that financial education and vocational trainings Were very important for a successful life. He welcomed Aflateen+ interventions and was hoping to include this curriculum in other districts of Balochistan.

#### Gender-Sensitive Global Citizenship and Life Skills Education for Youth



The National Integration Workshop on 20 november, 2021 included the representatives from the most important educational institutions of STEDA, PITE, Curriculum Wing, PPIU, district education departments and civil society organizations..

The session included Aflateen+ curriculum mapping with provincial curriculums.

After the presentation on "Approaches to integration" the two provinces chose "infusion" (topics added to the relevant subjects), for integrating the Aflateen+ curriculum with the subjects being taught in schools.

اس پروجیکٹ کا مقصد 34 اسکولوں،12,000 طلبا کو صنفی حساس کی تعلیم فراہم کرنا ہے۔ اس کے لیے 69 اسکول یوتھ کلب بھی بنا ے جائیں گے سندھ اور بلوچستان کے محکمہ تعلیم سے منظور شدہ نصاب پر اساتذہ کو تربیت فرہم کی جا رہی ہےپروجیکٹ پرکام کرنے کے لیے 34 سکولو ں اور 6 سول سوسائٹی آرگنائزیشن کا بھی انتخاب کیا گیا ہے۔ سکھر میں سیکنڈری اسکول کے25 اساتذہ کوتربیت دی گئی ہے۔

نومبر 2021میں کراچی میں نیشنل اسٹیک ہولڈرز کانفرنس منعقد ہوئی۔ کانفرنس کے ماہرین کے پینل میں سیکرٹری تعلیم اور دیگر اداروں کے نائندے شامل تھے .

#### Sahil Cruel Numbers 2020

"Cruel Numbers" is Sahil's signature publication having facts and figures with desegregated data on child sexual abuse cases, abduction, missing children and early marriages, across the country. The data was collected from newspapers, including national and regional editions of English, Urdu and Sindhi newspapers daily.

This year Sahil Cruel Numbers report 2020 was launched virtually on April 8, 2021, due to COVID 19 pandemic restrictions on large events.

Sahil 4 Regional Offices conducted 4 press briefings on Cruel Numbers 2020. A total of 69 journalists attended these press briefings

#### **Highlights of Sahil Cruel Numbers 2020**

This year, Sahil's flagship publication of 'Cruel Numbers 2020' has been compiled by the monitoring of 84 national and regional newspapers, daily.

The objectives of this report are:

- To present the data of the situation regarding violence against children (up to 18 years) in cases of sexual abuse, abduction/kidnapping, missing children, and child marriages.
- To contribute towards spreading awareness and information about different forms of Child Sexual Abuse (CSA) to all segments of the society.
- This data is relevant for researchers, academics, media houses, and legislators to work on strategies for the prevention of abuse against children.

The data of child abuse cases shows that a total number of 2960 cases have been reported in newspapers. These cases were reported from all four provinces including Islamabad Capital Territory (ICT), Azad Jammu and kashmir (A JK), and Gilgit Baltistan (GB).

In the year 2020, a slight increase can be seen in child abuse cases. These cases have increased 4% as compared to the last year's data of 2019.

The data shows that in a day more than 8 children have been abused during the year 2020 of 51% girls 49% boy victims.

That children are most vulnerable to abuse in the age group 6-15 years. More boys than girl victims were reported in this age group Moreover, children less than-5 years are also sexually abused.

In the year 2020, out of the total 2960 reported cases, 1915 (65%) cases are reported from rural areas and 1045 (35%) cases are reported from urban areas.

In the year 2020, reported cases of child abuse 87% of cases were registered with the police.

This year, a total of 834 cases of abduction have been reported from newspapers. Out of these cases, 74% of cases were of girls, and 26% cases were of boys. The reported cases of abduction, 494 (59%) c ases occurred in rural areas and 340 (41%) in urban areas.

The analysis of the data shows that total of 345 cases of missing children were reported, out of these cases 86% of cases were boys, and 14% cases were girls.

In the year 2020, a total of 119 cases of child marriages were reported. Out of the total 119 reported cases, 95% cases were of girls, and 5% cases were of boys.

The Cruel Numbers data of the year 2020 reveals that acquaintances are on top of the list involved in 1780 cases of child abuse, over of these 109 cases were service providers like {molvi, teacher, shopkeeper, driver, doct or, police}. 91 cases were family members and relatives, and in 92 cases neighbors were involved. In 468 cases, strangers were involved in abusing children.

The report found that in the geographical areas, 58% of cases were reported from Punjab province, 29% cases took place from Sindh, 7% cases from the KP, 3% cases from the Islamabad Capital territory, whereas 53 cases were reported from the Balochistan, 18 cases from Azad Jammu & Kashmir (AJK), and 4 cases were reported from Gilgit Baltistan (GB).

The analysis of Cruel Numbers data was published in 79 newspapers of the 4 districts and telecasted by 21 television channels.

Sahil's data and information was published in the form of articles, editorials and news in 158 newspapers and 21 times on different TV channels.

Sahil Cruel Numbers data was shared through posts and videos on Facebook, Twitter, Instagram and You Tube.

Sahil received 253 likes, 45,722 impressions and 2467 engagements.

#### Child Friendly Newspaper (CFN) Award

Media is a very important stakeholder not only to highlight cases of child abuse, but also play its vital role for the prevention of this crime. Sahil always acknowledges the contribution of print media over their sensitive reporting on child abuse cases.

This year again due to COVID-19, Sahil did not hold it's annual Cruel Number launching event.

However, Sahil arranged 3 smaller events, one each in Islamabad, Lahore and Sukkur, for the CFN award winner.

The National Category of the Child Friendly Newspaper Award was given in Islamabad to Daily Dunya. The Regional Category Newspaper Award went to Daily Pahenji, Sukkur.

A total of 72 participants, including media persons, attended these events.

#### Sensitization on child protection and media reporting

Sahil Head Office and Regional Office Abbottabad conducted workshops on sensitization on child protection and media reporting with representatives of print and electronic media. A total of 58 participants attended this events.

#### Child protection awareness campaign through cable network

To disseminate child protection messages for the larger public, Sahil conducted awareness campaign through cable networks from Sahil Head Office and 4 Regional Offices. Sahil animations on 5 different protection messages were shown for a period of one month. The total viewership was 3.75 million in the 5 districts.

#### Child protection awareness campaign through radio

Sahil developed audio version of animated child protection messages. The messages were broadcasted from Power 99, Hot FM 90, FM 100 and Radio Pakistan. These channels have access across the country.

#### **Sahil Services**

Sahil provides two free services, legal aid and counseling.

#### Sahil free legal aid

Sahil has 6 legal officers in its 5 offices, and a referral network of 172 lawyers across the country to take up cases of child sexual abuse, early marriages and cases of domestic violence of women. These services are available across the country

Sahil provides free legal aid services to the victims of child sexual abuse, early marriages and women victims of domestic violence.

Free legal aid offer letters are sent to victim families of all the reported cases that are monitored by Sahil. This year 1646 victims were sent letters. The addresses are confirmed from the police station. case addresses are not complete the Investigation officer agrees to give the letter to the complainant.

Sahil is dealing with a total of 159 (82 boys and 77 girls) on going cases of child sexual abuse and 22 cases of domestic violence.

Out of 159 CSA cases, in 8 cases abusers were convicted, 36 ended with compromise, and in 14 cases victim families dropped the case. where as one victim engaged there own lawyers. A total of 100 CSA cases are pending for trials.

Out of 22 domestic violence cases, 5 cases were decided in favor of victim family, and 17 cases are pending for trial.

Domestic violence cases were registered for marriage dissolution (khula), maintenance, and child custody. Sahil referral lawyers' services were engaged for up 56 cases across the 4 provinces.

#### **Sahil Free Counseling**

Sahil free counseling services are available with psychologists in Sahil's 5 offices. These services are available for children and adults who are in need of psychological support to overcome trauma of violence or other needs, such as behavioral issues, marital issues, depression, and anxiety. Sahil counselors also have referral lists of psychiatrists, doctors, hospitals and drug clinics. Any client with specific needs is referred to the relevant service provider.

Sahil provided counseling to a total of 139 individuals including 93 women and girls, 47 men and boys Counseling was provided through different modes such as in person, email and telephonic.

Sahil counselors received 28 queries regarding Sahil interventions of child protection, legal aid and counseling services.

#### Sahil Relax Online Counseling

Relax is an online counseling website <u>www.sahilrelax.pk</u> developed by Sahil. It not only helps adolescents to identify their issues but also provides strategies to deal with them. A referral list is also provided for further assistance.

#### Sahil Volunteer program:

To increase program outreach Sahil disseminates child protection messages through volunteers. They send requests to register as a Sahil volunteer. Sahil volunteers are from many different professions, such as, doctors, lawyers, teachers, local activists, and students.

Sahil has a total of 1295 registered volunteers, including 1106 men and 189 women.

This year 32 new volunteers registered with Sahil.

Sahil conducted one networking meeting with volunteers in Abbottabad. A total of 16 volunteers, including 9 men and 7 women, participated.

Sahil volunteers disseminate Sahil child protection messages in their communities, monitor newspapers, send child sexual abuse cases, arrange training events and write articles for Sahil magazine.

Contributions of Sahil volunteers in 2021 are as follows:

- Referred 45 CSA cases to Sahil
- Displayed 5 Sahil FIR posters in 5 police stations

#### Sahil Internship Program:

Sahil received 25 requests for internship. However, due to COVID 19 restrictions Sahil could only facilitate only7 interns for their study requirements.

Sahil provided required information to 18 students to complete their research work on child sexual abuse. They came from 14 national colleges and universities, and one international university.

#### Sahil Library:

Sahil maintains a library for interns and research students for reference material. The Library has 2920 books, and 418 CDs.

# INDEPENDENT AUDITOR'S REPORT TO THE BOARD OF DIRECTORS OF SAHIL

#### Opinion

We have audited the financial statements of SAHIL (the Society) which comprise the statement of financial position as at June 30, 2021 and the statement of income and expenditure, the statement of changes in funds and the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of as at June 30, 2021 and of its financial performance and its cash flows for the year then ended in accordance with approved accounting and reporting standards as applicable in Pakistan.

#### **Basis for Opinion**

#### Material Uncertainty relating to Going Concern

We draw attention to note 1.2 to the financial statements which indicates that during the current year Sahil has been executing a single project "SMILE" funded by the Norwegian Embassy that is due to be completed in the month of November 2021 without further extension granted to date. As stated in referred note the above condition indicates the existence of material uncertainty that may cast significant doubt on the SAHIL's ability to continue as going concern as its operations were solely comprise of SMILE project. Our opinion is not modified in respect of this matter.

#### Responsibilities of Management and those Charged with Governance for the Financial Statements

The management is responsible for the preparation and fair presentation of the financial statements in accordance with the approved accounting and reporting standards as applicable in Pakistan, and for such internal control as the management determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Society to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and
  whether the financial statements represent the underlying transactions and events in a manner that achieves fair
  presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
